Abstract:	The Gender Education Training Network, GETNET was a feminist political education organisation formed in 1995 in South Africa. GETNET serviced organisations, institutions and clients in South Africa and the SADC region. GETNET is the first organisation in the NGO sector in South Africa to have developed a pool of skilled gender trainers and to offer gender training for transformation.

Introduction

The Gender Education Training Network (GETNET) was a feminist political education organisation formed in South Africa in the 1990s that is best known for creating spaces of thinking and learning to strengthen action and intervention at numerous levels from 1992 to 2014. Recognising the need for gender transformation, GETNET was the first gender training organisation in South Africa that aimed to provide interventions to transform gender relations within South African society. The GETNET programmes were based on four key activities, namely gender training, research, materials development and regular networking events.

Notes

The collection consists of a digital archive covering the organisational operations of GETNET, its work in respect of gender training workshops, research papers, publications and training materials to name but a few of the materials within this collection. The collection further consists of a material based archive which still requires processing before it will be accessible to the public.
