## Introduction

When the Nationalist Government banned the African National Congress (ANC) on 8 April 1960, the ANC began operating underground in South Africa. Outside the country the ANC started to establish itself as the official voice of South Africa's voteless masses. By the 1970s recognition of the ANC's legitimacy was growing, not only amongst the multiplicity of non-governmental anti-apartheid organizations, but also among foreign governments.

The first missions were opened in London, Accra, Cairo, and Dar-es-Salaam. By 1980, the ANC had offices and representatives in 32 countries. The external missions worked to win support for the overthrow of apartheid by promoting the cause of the ANC and urging international economic pressure against the South African government. The missions also provided assistance to South African exiles. Following the banning of the organisation, Oliver Tambo, President General of the ANC left South Africa to head of the ANC's external operations.

On 2 February 1990 the bans on the ANC and other political organisations were lifted. A process of negotiations between the unbanned organisations and the South African government ensued. In 1992 the ANC instructed its missions to collate and box their records for shipment to South Africa. These records were to form the basis of the official archives of the ANC, from which a true history of the ANC's role in the struggle against apartheid could be written.

## History of the Netherlands Mission.

The Netherlands was an important centre to the ANC in the anti-apartheid struggle. There are historic ties with Holland, the country of the Dutch East India Company which bore Jan van Riebeeck to its shores in 1652 and turned South Africa into a haven for white settlers and later European imperialist expansion. A considerable number of Dutch people feel a debt is owed South Africa and were enthusiastic participants in anti-apartheid groups, aside from those who inherently opposed racism.

The headquarters of the Shell Corporation are based in Rotterdam and provided a focus for protest in the form of pickets and blockades. However the ANC mission was not immediately set up in Amsterdam, but until 1988 operated from Brussels where Godfrey Motsepe was the Chief Representative and Rose Motsepe was the women's co-ordinator organising and working towards a planned women's conference. They took up their posts in 1981, responsible for the Benelux countries of Belgium, Netherlands and Luxembourg. They forged strong links with Dutch organisations, South Africans and friends living in Holland.

A number of solidarity organisations were formed, with different political positions. The AABN (Anti-Apartheid Beweging Nederland) were more radical than the larger Labour-aligned Holland Committee on South Africa(KZA) while Kairos, a Christian organisation were mainly engaged in educational links and AWEPAA (Association of Western European Parliamentarians for Action against Apartheid engaged in many projects for South African students and workers. All worked closely with the ANC members in Holland and with the mission based in Brussels.

Women's organisations were mobilised by full-time worker Bunie Sexwale. Together with Rose Motsepe stationed in Brussels they organised a highly successful 30th Anniversary Women's Day on August 9, 1986, commemorating the 1956 March to Pretoria of 20,000 wormen against the pass laws. A pioneering conference which brought to Amsterdam for the first time in the apartheid years, 100



women direct from South Africa in January 1990 was paid for by Dutch Anti-Apartheid (AABN). Women's organisations and the general anti-apartheid movement helped to make the Malibongwe Conference a great success attended by women internationally.

In September 1988, Kumar Sanjay was Head of the ANC Information Bureau in Amsterdam and was appointed Chief Representative of the new Mission in November. He proved to be an energetic worker, who initiated meetings with groups hitherto unsympathetic to the AAM. The atmosphere of change in the air, had Shell approaching the Mission for talks. Sanjay held the position until May 1991, when Zolile Magugu took over. The nature of conferences then changed to post-apartheid concerns such as pollution and regeneration of education. The Dutch had been keenly supportive, both with teachers and material needs of the Solomon Mahlangu Freedom College in Tanzania opened after the Soweto students' uprising. In the 90's that interest and support continued.

#### Scope and Content Note

The Netherlands Mission papers of the ANC are stored in 43 boxes.

The papers are divided into 6 series: Subject, Correspondence, SA Embassy Newsletter, News Clippings, Publications, and Posters and Memorabilia.

Additional material has been added. This is of material that came with the material but for one reason or another was not processed with the material. It was later processed and added to this record group. It has been divided into 4 series: **Correspondence**, **Discussion papers**, reports and statements.

#### The Subject Series I is consists of 25 boxes

Folders 1 – 19 contains ANC reports from commissions, conferences, missions and the CODESA negotiations. Folders 20 – 30 holds reports on projects, anti-apartheid movements, COSAWR and Bantustans, Folders 31 – 44 contains conferences, COSATU, Dutch delegations the economy, and education. Folders 45 – 55 has elections, SA incursions into Angola and Mozambique, faxes in and out, the Harare Conference and health material. Folders 56 – 71 holds information on Helen Joseph, Kairos, KZA, Land, Mandela's visit to Holland, the UDF and others. Folders 72 – 85 holds **inter alia** reports on Nelson Mandela, NGO's the post-apartheid constitution and RECSA. Folder 86 – 95 is on sanctions and the SA-Netherlands Cultural Centre. Folders 97 – 106 contains an interview with an ANC Rep, Tambo speeches, violence within the organisation, Sisulu Winnie Mandela, Women and Zambia. Folders 107 127 a mix of folders some of which are the same as earlier ones and these are indicated on the finding aids, e.g. CODESA, ANC policy and Women's Section, Dutch Government and correspondence.

The **Correspondence Series II** is in Boxes 23 and 24. It contains Incoming mail in folders 1 to 3 and Outgoing in folders 4 to 7. Correspondence dates from 1985 to 1993 and is mainly from Dutch anti-apartheid organisations and ANC Lusaka.

The SA Embassy Newsletter Series III is in Box 24 to 27 holds folders 1 to 13, dating from 1992-1994. The newsletter informed missions of the progress of the CODESA negotiations, inter alia.

The News Clippings Series IV is in Box 28 to 29 holding folders 1 to7 and also contain some articles. They date from 1992-1994.

The **Publications Series V** are contained in Boxes 30 to 38. Removed some publications, especially ANC material and it's allies to be added to the special section

#### The ANC Newsbriefings removed

The **Posters and Memorabilia Series VI** are contained in Box 39 and consist **inter alia** of Dutch and anti-apartheid posters, flags, postcards and a diary of Kumar Sanjay.
