ANC funding proposal London 1990 – 30.79

Funding proposal for "Consultative meeting of the Department of International Affairs". Conference objectives: "1. To bring together all those structures of the movement in international mobilisation; 2. To bring together experiences of all our missions and other international representatives of our movement; 3. To prepare well informed input to the National Consultative Conference; 4. To identify areas of and donors for training in international relations." Total budget: ZAR195,000.

ANC-Germany relations 1990 – Germany 4.24

Budget proposal to the Gov. of the Federal Republic of Germany. Appeal from Tambo and Mandela. "We know that these formidable tasks require enormous material and financial resources, and can be realised only with your continued support. We therefore appeal for your assistance during this final phase, cognisant of your previous and consistent solidarity. We acknowledge the enormity of our request and would appreciate a phased contribution commencing as soon as possible." Funds required for setting up offices, transport, logistics, etc. Grand total of transport request: USD30,726,000. Department of Legal and Constitutional Affairs grand total: USD3,032,640.

Armscor deals 1992 – Washington 70.235

Fax from Lindiwe Mabuza, chief rep in DC, to Pallo Jordan. Contents: news extracts on case of James Guerin, former arms dealer, and sentence of *"15 years in prison for smuggling \$50 million in weapons to South Africa and laundering \$958 million in gains… Some components reportedly ended up in the Iraqi army and were used against American forces during the Persian Gulf war"*.

Assassinations 1988-1989 – France 31.47

Translated report on TV programme entitled "Who ordered the assassination of Dulcie S.?". "[T]he Frankfurt based journalist Jürgen Roth pounced upon agents of South Africa's military intelligence service. Their activities... extended not only to France, Belgium, Great Britain and Switzerland, but also to the Federal Republic of Germany." Implicates Joseph Klue and Dirk Stoffberg.

Document of "notes taken concerning the assassination of Cde. Dulcie September at lawyer's office on 19 January 1989". "Lawyer informed us that the Dutch journalist indicated that the person who assassinated Cde. is names Tran Lien". Other details of people on whom suspicion fell, including Richard Rouget and his former girlfriend Antonia Sotan. "Both have a history of extreme-right affiliations dating from their encounters as a Paris university". Some detail on them.



Belgium memos and circulars 1992 - Belgium 1.0005

June 1992 "Report on a Belgian government meeting on South Africa and visit by Gerrit Viljoen to the European Parliament... The presentation was based on the finding of the economic prognosis conducted for Nedbank and Old Mutual. The meeting was attended by, apart from government officials, members of Belgian political parties, businessmen, the members of the EC and Southern African ambassadors. The conclusion of Bob Tucker is that South Africa faces grim economic prospects and the situation has to be reversed immediately. According to him the difficulties experienced at CODESA will continue for sometime and it would not serve good to wait for the installation of an interim government... This position was challenged by the ANC and it was argued that an interim government was the only way to restore confidence... ".

December 1992 fax from Mandela to all chief representatives of the ANC: "A key component of our section campaign is fundraising. Without a considerable levelling of resources, there can be no such thing as a free and fair election in South Africa. I therefore, in my personal capacity, as well as in the name of your organisation, call upon all our Chief Representatives to immediately embark upon major fundraising programme for the elections. ... I call upon you to extend your maximum assistance to the National Elections Fundraising Committee. Please consider this as one of the most important tasks we have ever undertaken."

Right-wing protest, with banner "Geen terroristen in ons stadhuis", brandishing tyres.

Solidarity music concert, with Johannes Kerkorrel?

Alfred Nzo, O.R. Tambo and Thabo Mbeki in serious conversation.

Botha visit to France 1984 – France Add 22.35

Report (presumably Dulcie's) on Botha's visit to France. "At a meeting (17/04/1984), with Comrades Jele, Aziz Pahad and myself, Jacques Hutzinger, head of Foreign Relations, French Socialist party, and Jean-Bernard Curial, French Socialist Party and director of CRIAA, assured us that Botha would not be visiting France. The following week I learned that Botha would be coming to France on a private visit." Various attempts to halt, organisation of demonstrations, analysis of position of allies (esp. Communist Party, which is criticised). Comment on French sale of enriched uranium to Koeberg, on French mineral and economic reliance on SA, on relations wrt nuclear collaboration, oil, and arms. Lists Snias, Matra, Snecma, Dassault "(partially)", Thomson C.S.F, TESA, CNE, CNES.

British gov selling out to apartheid – AAM publication 1989 - Tambo 74.788

Contents: "Foreword By Archbishop Trevor Huddleston Cr; Introduction -'Good Business To Be Done'; <u>Britain's Sanc</u>tions Obligations; Disinvestment Provokes New Trade Initiative; Official Green Light For



Apartheid Trade; Trade Missions — Favouritism For South Africa; Dti Ignores Nassau Accord; Dti Instructs Staff To Push Trade; Botb Promotion Of Trade Missions; Botb Chief Pays Special Visit To Sa; 'All Other Assistance Continues To Be Available'; Companies Fail To Meet The Trade Mission Challenge; Market Reports From HMG; Mossel Bay — Breaking Two Sanctions At Once; Computers For The Military; Ban On Tourism = Promotion Of Tourism; DTI Doublethink On Namibia; DTI Breaks New Ground And The Cultural Boycott; Conclusion."

Chilean connection 1988-89 – Belgium 2.12

Press release: "The World Campaign Against Military and Nuclear Collaboration with South Africa has been able to confirm that the South African defence minister, General Magnus Malan, left for Chile last week on a two-week visit to promote closer military collaboration between the two countries. One of the projects involves the assembly in Chile of the South African G5 155mm artillery gun in order to penetrate markets which are normally denied to South Africa... The World Campaign believes that South Africa intends to reach an agreement with the Chilean authorities to build submarines there, based on the blue-prints obtained from the Federal Republic of Germany in 1985... Pretoria's links with Chile, Israel and Taiwan are crucial for its military programme." A few more details of trip.

Fax from Sotiros Mousouris at Centre against Apartheid, PSCA: "The mission of Chile to the United Nations informed the Special Committee against Apartheid on 30 March 1988 that the exhibition of any equipment in the FIDA 88 did not involve any contractual obligation with regard to the purchase or sale of such equipment. It was virtually impossible for the government of Chile to take action against the participation of South Africa at that advance stage of preparation... The government of Chile expressed its emphatic rejection of the policy of apartheid of South Africa."

Chilean connection 1988-89 – Belgium 7.59

Doc on South Africa in Chile. "The military government in Chile is South Africa's main ally in Latin America. The white South African regime plans its diplomatic offensive and its arms sales for the whole hemisphere from Santiago. And recently these operations have taken on worldwide implications. Chile is about to become South Africa's tool for mocking the UN embargo on arms sales." Details on FIDA, arms exhibition at which SA was present. "No other organiser of this kind of event allows Pretoria's presence. Usually South Africa has to deal with its potential clients in hotels and show them catalogues and videos... The North American magazine Time reported in May 1988 that Armscor...'now has orders worth 4.500 million dollars. Most of these contracts were signed at the international arms exhibition in Chile in March'... A major jump in relations between Cardoen and Armscor (with the blessing of both governments) is the assembly in Chile of the long-range canon G-5...". Suggestions made for how to protest/counter.

Chilean connection 1988-89 – France 17.84



OCR with OCRkit. "The Chilean Connection" – "The South African regime has long desired to integrate itself into a South Atlantic military alliance, and it has forged close military links with a number of South American states. Chief amongst these is Chile, which is similarly isolated in the world arena as a result of its repressive and anti-democratic politics... South Africa is not the second largest holder of foreign assets in Chile and since 1984 companies from each country have participated in the other's trade fairs..." Sandock-Austral connection.

Coded letter 1964 – Lusaka 3.17

Letter in code, with uncoded text worked out. Apparently involves financial arrangements for Rivonia trial.

Conference SA military nuclear build-up 1982 – Tambo 59.559

AAM conference publication. Largely rhetoric, but some detail. "The Strength of the Military: In the past two decades the regime's annual military budget has increased by over 4000% (from R72m in 1961/2 to over R3,000m in 1981/2). During the same period the total strength of the SA Defence Force has increased by 55% (from 79,000 in 1961 to 515,000 in 1981) and the standing operational force (ie the number of troops under arms at any one time) by over 1500% (from 12,000 in 1961 to 200,000 in 1981). In the past five years approximately R5,000m has been spent on weapon procurement and military capital investments." Some rough figures of numbers of tanks, aircraft etc. and on operational strength of police.

"The Military-Industrial Complex: In an attempt to render itself largely self-sufficient for its basic weapons requirements, the regime has, in a space of fifteen years, built the largest military industrial complex in the southern hemi-sphere. The state-owned Armscor and its nine subsidiaries have an annual turnover of more than R1,000m. Armscor employs over 20,000 and contributes to the employment of about 100,000 in the private sector where more than 800 companies are involved in Armscor contracts. Joint development projects with countries such as Israel and Taiwan and the continued unrestricted flow of high technology, particularly electronics, into South Africa, are enabling the regime to enter the international arena as a middle-power arms producer and supplier. Despite its claims of self-sufficiency, the armaments industry is highly dependent on the importation of technology and parts."

Some rough details on operations in Namibia, and on nuclear activities. Also on extent of current embargo violations, but largely non-specific. Names only British violations: ICL, Plessey, Cementations Engineering, Marconi, Redifon, Leyland, Rolls Royce, mercenaries.

Correspondence after death of DS – France Add 5.79

1989 Letter from Paul Rechsteiner to Solly Smith, enclosing several letters from Swiss authorities (in German), on Dirk Stoffberg and Swiss connection to Dulcie's murder.



Correspondence after death DS – France Add 6.98

Lawyers' correspondence (in French), on gaining access to the dossier. Letter from Solly Smith to Stephanie Arendse, on funeral costs and need for her to sign a declaration of domicile form for the sake of the civil action. Handwritten notes on lawyer Roland Dumas (*"Can he become part of collective of lawyers?"*) and intention to make civil action.

Correspondence after death of DS – France Add 6.110

Document on the case against Richard Rouget. Another document (in French, translated by hand) on "Tracks", including of Rouget, Tran Long, Jean Taousson, Victor Kelly, Gary van Dyke, Joseph Klue.

Correspondence after death DS – France Add 6.115

Letter from AAM to Tambo. Complaints about Solly Smith compromising solidarity (e.g. insisting on PAC exclusion from conference). *"We regret that following all these incidents, cordial relations could not be re-established with your representative in Paris. We consider such relations indispensable, but they cannot be established on an authoritarian conception of relations between the A.N.C. and our organizations of solidarity."*

Correspondence on threats to ANC people 1985 – France Add 9.152

Letter to SA morning newspapers from the West European Suicide Squad, threatening violence against ANC members. Claim to be expat Brits, Irish and Dutch.

Message to SG's office with Sowetan extract that "South Africa's National Intelligence Service has been recruiting mercenaries in France in the past few weeks to attack ANC and SWAPO targets in Europe...recruited mercenaries from among the security forces of extreme right movements". Comments that: "We have already received a number of threats here and are taking them very seriously".

French text quoted above, in Liberation.

Correspondence Ritchie Fauntroy Boesak 1986-87 – Lusaka 3.20

Letter from Peter Ritchie to Archbishop Trevor Huddleson, involving Mr Robert Applebaum, also involved in the Sun City project, who: "has been advised by Congressman Walter Fauntroy that three major American companies are going to divest themselves from South Africa and would like to contribute their assets to black organisation... Could you assist me in setting up an appointment...between Robert and [either Thomas Nkobi, Thabo Mbeki or Sizakele Segxhashe]?"

Encloses letter to Rev Boesak from Fauntroy, on "the establishment within South Africa of a legal entity which could take title to the assets of disinvesting US corporations and either operate them on behalf of the black community or facilitate their re-transference to black South Africans who are capable of operating them effectively".



Fax cover page, via Bowman-Gilfillan-Hayman Godfrey Inc., from Appelbaum to Ritchie, indentifying Ritchie as from Capitol Records. Gives details of those to call to check credentials (congressmen Fauntroy and Gray, Tutu, Boesak, Francis Wilson).

Correspondence with banks 1991 – Washington 36.30

Letter to Tambo (cc Mandela and Sisulu) from Napoleon Nobay of First City, Texas. "Since last year, your son Dali and I have been in discussions on a broad range of initiatives... We determined that one of the more pressing initiatives...is the need for a Commercial Bank owned, operated and managed by the majority of the peoples of South Africa." Gives detail on similar experience in Kenya. "At the risk of being presumptuous, I strongly urge your Organization and your Leadership to consider commercial banking in tandem with your political efforts." Gives the hard sell. "I do hope that I can be a part of the initiative and play a role in its formation."

Letter to Sally Bowles (ED, Committee for SA Development) from same as above. "To reiterate part of our conversation this morning, let me say that I would very much like to work for you setting up the Development Bank." Etc.

Craig Williamson campaign manifesto – London Mayibuye 31.15

"To a large extent, the battle for political power in South Africa is a battle for economic control... In this pamphlet I expand on my own personal belief in the free market system as the system which allows for enterprising individuals to develop a healthy society that promotes both political and personal freedom. I believe that this can only be achieved if we lobby for, and develop, an aggressive, growth-oriented free market strategy for South Africa." Etc. with lots of rhetoric on lowering taxes, the failures of socialism etc.

De Klerk visit – Belgium 8.68

European trip itinerary May 1990, with AAM plans (i.e. protests) in parallel. Meetings with Miterrand, Kohl , Thatcher, Andreotti etc. Belgian meetings: BVO ("Employers Organisation"), President of House of Lords, Foreign Minister, PM, possibly King – far more than elsewhere.

De Klerk visit – Belgium 8.74

In Dutch. On VBO (above incorrectly called BVO), and restarting economic relations with SA.

Dissertation French policies towards SA 1989 – France 57.106

Dominique Hudson's University of Southampton 1989 MA dissertation. "This dissertation examines the relationship between France and South Africa under the Fifth Republic. ... The introduction

historical link between the two countries. ... Chapter IV relates how the nuclear and



military relationships between France and South African pursued under successive government resulted in South Africa's atomic independence and in its ability to arm itself. ... Chapter VI gives a survey of the pro-South African lobby in France. It shows how, allied with the world of business and finance and led by personalities from the right and extreme right of the political spectrum, it has infiltrated French political and economic structures."

Gives names and known details about nuclear and military collaboration. There's a lot here, not so much new facts as useful contents, and in useful narrative form, but some extracts:

"According to the Swedish International Peace Research Institute (SIPRI) forty-four per cent of South African weapon imports came from France in the 1960s and between 1970 and 1974 this percentage increased to over half. Innumerable companies, some nationalised, were involved..." (p74).

"On the contrary recent observations confirm that France's involvement in South Africa is the reflection of a policy serving both its interests and those of South Africa, perpetuating the role of South Africa as "gendarme" for the West in South Africa, perpetuating its sense of belonging to the Western camp, of a policy more preoccupied with maintaining and extending French influence in Africa than with dismantling apartheid" (p80-81).

"South African agencies and French interested parties... all have contributed to form a strong pro-South African lobby in France which diligently works at moulding French opinion... A survey of the lobby's activities reveals the impotence of the French government in the face of the immense power of big capital." (p105) Lists institutions involved, including South Africa foundation, Club of Ten, Groupe d'Amitie, Taousson etc.

DS Assassination 1988 - France 32.52

Document "Entries of spies and their helpers", unsigned. Series of statements amounting to narrative of Stoffberg's responsibility and UK and French complicity. E.g. "An SADF-captain tells somebody that he is being trained by the British Ministry of Defence in Birmingham. MoD denies. ... In 1988 Dirk Stoffberg is stopped and interrogated at Heathrow. A man with him carries a 'hit-list'. After interrogation he is set free. ... Two days afterwards, Dulcie September is assassinated. For months there is no trail of perpetrators. Then, two names come up: Stoffberg and Klue. Both deny any involvement." Conclusion: "It seems that not only NIS-officers are involved in spying and other illegal activities in Britain. Also SADF- people, Armscor-people, businessmen from South Africa and ex-intelligence-officers in Britain are deeply involved. ... The only possible conclusion is that political high level collaboration between SA and the UK, with one aim: fighting the 'communist enemy'.... Probably, western intelligence doesn't like people being killed by South Africa in their territory. But no authority is prepared to confront South Africa by punishing or preventing its crimes, because of 'stability' in South Africa." Lists numerous unanswered questions.

Extract from an article in "l'Humanite" entitled "Destination Murder". "The assassination of Dulcie September, the ANC representative in France, confirms the existence, in spite of soothing statement frequently made to deny the fact, of pursued cooperation between the French and South-African [sic] police and intelligence services... It is an understatement to say that there are links between the



ational of Jean-Marie Le Pen and the Pretoria regime. These links extend to all the small

neo-fascist groups in France and Europe as a whole..." Some talk of Sun International and gambling as the SA entry point to the European market. Not much in the way of evidence.

"L'Humanite". "...the Home Minister had decided, some months ago, not to extend D. September's residence permit. ... According to Reuter, the adviser in relation with South African might be J.D. Taousson..."

"Le Monde": Quotes South African and French denials of involvement. "...a communiqué from the embassy declares: 'there is no logical reason for South African to be involved in such an absurd act'... 'It is in the interest of the South African government that the murdered be arrested as soon as possible, so as to clarify the case." French minister of Justice denounces "the bad habit which consists in exploiting death for political purposes". Mitterrand "declared that he had 'suspicions about the Pretoria regime... as far as D.September's murder is concerned, I can't say anything, even if I have an intuition... Apartheid is unbearable, we must reject it, struggle against it' but 'diplomatic relations don't depend on the opinion we have on a political system'."

"Le Monde": French government "neither rejects, nor confirms' the thesis about South African responsibility in the Paris murder".

"L'Express": "But to think that he [Botha] can have been tempted to use state terrorism in a country like France, in which he has every interest I preserving as 'respectable' an image as possible... We cannot reject the possibility for South African right-wing extremists to involve their country in a desperate policy."

"Le Point": "...who had an interest in eliminating D.September?... Acute tensions exist within ANC between communists and nationalists. Was D.September a victim of this struggle for influence? This what the Pretoria government is hinting at, and the French police doesn't reject the possibility. But South African secret services are at the same time suspected, in spite of denials..."

Lots similar from news sources.

DS Assassination newspaper clippings – France Add 18.32

"Le Monde", April 6, 1988: "*Mr F.Mitterrand refuses to break off relations with South Africa...* because they [diplomatic relations] 'don't depend on the opinion we have about a political system'... [This] is a slight reversal of gear, to get out of a minefield." Suggestion again that assassination by right wing groups against Botha's moderate reforms.

"Liberation", April 6: Upcoming non-renewal of September's residence permit. "According to the last issue of "La Lettre de L'Ocean Indien", a specialised magazine published in Paris, a member of C.Pasqua's present staff is supposed to have, 3 years ago, recruited mercenary on behalf of the South African secret services, to attack the ACO and SWAPO offices in France and in Europe... doesn't mention the name of the French civil servant concern but it was confirmed by the Home Ministry that he was J.D.Taousson, official in charge of harkis and rapatries in the Ministry. The same person, according to "La Lettre de l'Ocean Indien" is supposed, some months ago, to have given express orders to services concerned not to extend D.September's residence permit." More on Taousson link.



"Le Canard Enchaine", April 6: On Mitterrand's reluctance to break off diplomatic ties. "Last example of this friendly atmosphere: on March 12, two weeks before the murder, Pik Botha, South African Foreign Minister, waiting for a plane in Roissy, met several representatives of Chirac and J.B.Raimond. The quartet he met in a reception room at the airport was quite qualified. In the first rank, Michel Roussin, head of J Chirac's office, in charge of delicate missions. He was accompanied by his friend and unofficial adviser J.Y.Ollivier, a 43 years old "pied-noir" who is in very good relations with South Africa. In 1986 and 1987, that man negotiated (in violation of the embargo theoretically implemented from 1985) the import of hundreds of thousands tons of South African coal for French Industry. He participated, with Chirac's special envoy, in discussions which lead to the release of the French teacher P.A.Albertini. In a still more quiet way, he was conferred, on December 17, 1987, the Order of Good Hope by Pik Botha, during a moving ceremony in good old Cape Town."

"L'humanite", April 7: ANC says Paris did nothing to protect Dulcie, despite having been warned of danger, and that she was on a list of targets. AAM reps ask Paris to break off ties with SA.

DS Minutes of London meeting 1984 – France Add 13.8

Dulcie's minutes of meeting held in London on 10th October 1984, between TT Nkobi, Joe Jele and Dulcie September. Issues of funding via Jean-Bernard Curial from CRIAA and Socialist Party. "I am agitating that the work here should become more mass-based as opposed to this 'private' affair that the Anti-Apartheid Movement is." Concerns that the country is swinging more to the right. Money is tight. Handwritten notes on issues to be discussed – largely administrative stuff. Note on Nuclear Project: "Name of organisation – Les amis de la charte de la liberte – ANC. More audience. No directives, not even the statement. Unesco – statutes and full accreditation. Full observer state, invalid (?).

DS notes 1985 - France 6.114

Typed record of threats made against ANC and known suspicious incidents. Wire tapping at apartment and office. Office broken into. Harassment by Jean-Paul Horeau. Being photographed in the street. Handwritten notes mention: nuclear collaboration, Thomson (armaments and nuclear technology, communications equipment directly to the SADF), arms and Puma spare parts.

DS Notes on French arms sales to SA – France 15.71

Handwritten notes. Ship name Tine Maru. Names of people involved: Michel Floquet, Pierre Abramovich, Joergen Jensen ("the later created a false Panamian company in 1980 et resold the ship to himself 15 times its price and gave it the name which it used during the transportation of arms"), Henri Ferriere, Marc Millac, Tom Roesenberg. American company Commerce International, "which has an office, rather a mail box in Cagnes sur Mer... in close contact with Australian 'financial group' Nugan Hand". William Casey. From Bordeaux. "Name of ship on arrival in Durban: Nema. Flying under Panamanian flag, made 5 trips. Need to know when they arrived in Durban (dates)."



Doc from Abdul Minty to Minister for External Relations (as sent to Dulcie). "Your excellency may be aware of reports in Danish media about the supply of was material of foreign origin to South Africa in breach of United Nations mandatory arms embargo. The case involved persons and enterprises in several countries and Danish and Swedish authorities have already begun to investigate matter concerning five alleged shipments of war material, amounting to 2,000 tons, from Bordeaux to Durban during 1981-1982." Hopes the French will help investigate, commit to initiatives to prevent future cases.

Letter to Dulcy in French, saying attached report may interest her, and that Danish comrades may also be encouraged to help with the two journalists' research.

Customs document certifying that the cargo of the tanker Cast Puffin arrived at Verdon from Seal Sands, with crude oil, on 23 September 1980.

Cover letter of Port of Bordeaux, to SRB, of records of English fuel tankers Cast Puffin and Spey Bridge.

Details of Tina Maru ship, Tom Rosenberg.

More handwritten notes, mentions ship Nema, Samik Awad. Notes on phone calls with Abdul, Lindiwe in Sweden.

French article of which first set of handwritten notes are translation.

Notes mentioning Mr Du Plessis, son of rector of Bloemfontein University. Armines. Visit related to arms research.

Dulcie report on president's visit to Paris 1986 - France Add 22.39

June 15th to June 20th, 1986. "*The organisation of this visit was disastrous to say the least although I had two comrades to assist me… Together the three of us managed to foul up everything.*" Description of series of mishap involving meetings, transportation arrangements, concert that had to be cancelled, serious damage to reputation etc. Takes extraordinary amount of responsibility, despite it seeming that it was often the fault of one of the others. Disapproves of Breytenbach.



Extreme right international 1987-88 – France 57.107

In French. Headline: South Africa – convergence of right and far right! At the time of the release of Pierre-Andre Albertini there was a violent criticism from some political actors on the right against the activist who we salute here for his commitment to the fight against apartheid. These men are ideologically close to the National Front.

Names of right-wing and other actors' names highlighted. Jean Taousson mentioned.

Extreme right international 1987-1988 – France 57.108

In French. Headline: THE V.R.P. OF APARTHEID. Two French emissaries who negotiated the release of Albertini under exchange of prisoners between Angola and South Africa have recently been granted the Order of Good Hope, one of the highest South African distinctions. ?, it appears useful to return to the submerged part of the Franco-South African relations, namely, the South African lobby in France.

Faxes 1991-93 – France 33.57

From J Tillerson to Nat Pillay, on the Blowpipe affair (21/04/89): "According to articles of that period, one SA diplomat, Daniel Storm, was not exactly expulsed by the French government but after claiming diplomatic immunity in the affair, it was 'suggested' he leave France." Storm alleged to handle logistics for SA intelligence services, maybe involved with D September assassination.

From ANC Paris to Gen Sec DIA, att Yusuf Salojee, 28/04/92, re: Relations with French Foreign Ministry. "I have been informed by the French Foreign Ministry that they would like the ANC to prepare a package, listing our needs in the field of constitutional, educational and cultural negotiations. ... My difficulty is that I cannot gauge how far I can make demands or determine what has been and how this has been provided up until now. ... Finally, I would like to make the point that the rightOwing opposition attempts, every time it has an opportunity, to change the Government. To me, this means that the sooner we present our package and open a forum for dialogue than wait for another Government the better. Our relations with right-wing political organisations has dramatically improved. ... Their position is that they do not see the present ANC in the same light as the ANC that was once in exile. The RPR-UDF coalition representatives with whom I have already met, say that they are also willing to finance some of our work."

From ANC Paris to DIA, att Ally Lumkwana, 11/10/1993, re: Programme of SA delegation to France. Nelson Mandela and Thabo Mbeki to meet with: NGOs, Chirac, PM Edourd Balladur, Ambassador Burger and ANC chief Rep Mr Msizi, DG of UNESCO, Minister of Economy Edmond Alphandery, Chambers of Commerce, Alain Juppe, Socialist and Communist Parties, Mitterrand.

It should be noted that Thomson has economic, military, financial and enterprise investment in SA. Thomson-Electronics of SA makes communication material for the armed forces and radio. ... After consultation with legal department of another advertising agency here, the office was informed that IF cde Madiba accepts the use of his image, it is not normal practice for an individual to receive payment. However, it was said that it is considered acceptable for a donation to be made to an organisation such as the ANC. ... NB The ANC French Mission has to this date had no contact with Thomson."

"Liberation", 18/02/92: French enterprises on the SA springboard. "A contract was concluded yesterday between the EDF (electricity of France) and its SA counterpart, ESKOM. The embargo is almost a thing of the past and the agreement, which provides for 'common action' on the whole of the African continent, underlines the importance which French industries attach to the new African economic giant... The historic leader of the ANC recommends waiting further, until the setting up of an interim government... But alongside of this official political position, Mandela's organisation is multiplying its contact with European and American industrials willing to come invest in SA... A visit to the Headquarters of the ANC, in the center of Johannesburg, to meet with its economic experts has become a necessary route for investors."

"La Lettre de L'Indien Ocean", 26/01/92: South Africa – French business expanding. "Several French groups are realising an expansion of the activity in SA." "On the spot, at the initiative of the French Chamber of Commerce and Industry in Southern Africa (CCISA), numerous SA missions are sent to France." Including Wesgro.

Communique by C.Dufour, Deputy National Secretary for Human Rights, 1/2/91: The Socialist Party is glad about development in SA, encourages more progress.

Notice of nomination of Mme Joelle Bourgois as ambassador from France to SA.

"Agence France Presse Dispatch", 7/2/91: "An important French interministerial delegation arrived in Johannesburg for a visit of one week. Its mission it to evaluate new perspectives in increasing economic and financial exchanged between South Africa and France..."

ANC request to clarify statements in newspaper about expulsion of SA diplomats from France. Illegible.



"La Lettre de l'Ocean Indien", 29/04/89: South Africa – the Blowpipe affair. In French. On SA diplomat Daniel Storm etc. Rough translation: "*Receiving 24 April the South African Minister of Finance, Barend du Plessis, Margaret Thatcher was forced to express "grave concern" while the Foreign Secretary, Sir Geoffrey Howe tried to calm the Commons Labour MPs who demanded consultation between/with European countries about expelling all South African spies and arms buyers working under diplomatic cover.*"

Brief news piece in magazine, 15/5/90, on Sol Kerzner. In French. Rough translation: "South African casino magnate, Sol Kerzner, picked up in France, teaming up with Accor to restart the nicoise Society of sea bathing which operates the casino Ruhl Nice. Accor provided 120 million francs, and Kerzner 60 millions, in a transaction that has received the blessing of his former associates, the Group Lucien Barriere, and the green light of the French economic authorities. We remember that they were opposed it - but that was in 1987 – at the wedding of Kerzner and Lucien Barrier ... Kerzner is also said to have through Royal Resort International, a 34% stake in Casino de Divonne, which Lucien Barriere."

"Financial Mail", 29/4/90, The Lubowski affair - White lightning. "Pretoria attorney Ernst Penzhorn was used by Military Intelligence (MI) in October 1986 to evaluate a scheme, designed by a close friend of former President PW Botha, to give MI a foothold in African countries. Penzhorn recently claimed that he had, in early 1986, sold the close corporation which made payments on behalf of MI to slain Swapo executive member Anton Lubowski." A bit more on Project Witblits.

Teleks from Abdul Minty, World campaign against military and nuclear collaboration with South Africa, to Mitterrand, 9/11/89. "According to reliable information which we have received the French government has apparently agreed to modify its earlier policy and decided to authorise the delivery of SNECMA Atar aircraft engines to Israel Aircraft Industries (IAI) to power the Kfir fighter plans which was unlawfully copied from the original French Mirage. ... It is possible that Israel has mentioned some of these countries as possible customers without mentioning South Africa in view of the firm policy of your government against the apartheid regime. ... We are sending this information and urge that your government order an immediate and urgent investigation..."

"SouthScan", 1/12/89, "U-boat, jet engines, missile technology continues to flow to Pretoria". Germany condemned for sale of submarine plans. France/Israel/SNECMA/Kfir case. US investigating whether Israel gave SA US 'Star Wars' tech. Congress grappling with the implications of Israeli-South Africa military collaboration.

"Le gouvernement Chirac après 90 jours", 24/6/86. In French. Chirac's military advisor, Francois Bujon, has a team of 6, including Jean Pico - formerly of Aerospatiale. Some policy details but no shift on South Africa.

German economic collaboration with SA 1981-1985 – Germany 19.131

"The Independent on Sunday", 30/12/90 – Germany crashes the sanctions barrier. "As South Africa emerges from the era of sanctions, it is clear who its best friend has been. A South African submarine scandal is threatening to turn into the first foreign policy embarrassment for the united German



erman government says it stopped the illegal transfers in 1985 and that South Africa

received too little information to build the vessel. But now an Oslo-based anti-apartheid group says South Africa continued to receive blueprints and expert information from the companies – enough to build the submarine – until at least January 1987." Indication that Durban harbour was re-equipped and that other work was being done in CT. "But [according to German law] the secret transactions must be shown to have caused 'sever damage to Germany's external relations' before the companies can be prosecuted for having committed a crime. So despite the new evidence, a regional court in Kiel recently ruled that the companies can be charged only with an administrative offence," with minor penalties. "Anti-apartheid groups say the submarine case is just one example of how German firms have ignored the sanctions, including a voluntary ban on new investment in South Africa. Even some German businessmen scarcely bother to conceal what is going on. 'The only awareness of sanctions is not to get caught busting them'...The agent says that when equipment or goods cannot be exported directly from Germany, a frequent conduit is Turkey... Austria has also served as a conduit." Some more details on how it works, including financial mechanisms. "When sanctions-busting requires financing, it is often arranged through banks that transfer funds to South Africa for a legitimate project. The project is purposely allowed to collapse, but the funds cannot be removed from South Africa because of exchange controls. So the money goes to those it was always intended to reach, thus backing a sanctions-busting investment."

In the last years, the CSU held yearly seminars on military aspects and made sure that officials from the South African embassy are invited but not the ANC... The government here called a meeting of all German foundations some six weeks back and encouraged them to assist the ANC. Discuss the issue with Cds. there especially policy on how to related to such bodies vis-à-vis funding".

Policy response. More info on the Hans Seidel Foundation. "They will NEVER support or agree with ANC policy.....Nevertheless, we will in the light of the above, have to adopt a 'realistic policy' towards them." A number of versions of these documents.

Against apartheid, for democracy and constitution etc. "*The federal government is contributing toward a quicker end of apartheid through its continuous dialogue with all of the politically and socially relevant forces… The federal government believes that it and its European partners must put pressure on SA until apartheid is legally and de facto abolished… The step-by-step loosening of restrictive measures that has been decided on by the Council of Europe makes it possible to continue the pressure on the SA government… The restrictive measures of 1985 are still in force. So far, the lifting of these measures had not been on the programme of the European Political Cooperation. Insofar as these measures coincide with the resolutions of the UN Security Council, e.g. regarding the weapons embargo, they are not within the jurisdiction of the Twelve.*" Also policy on Inkatha.

10/10/91 Doc by Hans Brandt: "You can't blame us for that" – "For years, the Konrad Adenauer Foundation has been spending million to finance the Inkatha party of SA, which has been involved in violence / The main beneficiary: an institute that is close to the Inkatha part and claims to be the 'Ministry of Information' for the KwaZulu Homeland... Kerchner emphasizes that the KAS has recently made efforts to make contact with the whole spectrum of political organizations in South Africa. 'You can't blame us for having worked closely and almost exclusively with Inkatha,' he says. 'Inkatha was the only black organization in South Africa that could survive. What was the KAS supposed to do?'... Nonetheless, the scandal concerning the secret funding of Inkatha by the Ministry of Police is embarrassing for the Foundation. Close contacts to Mangope... funded the DIA and sponsored the Institute fur Managementberatung... has long-standing links to UNITA... have been extremely shy on their contacts with Renamo. Nevertheless, there is evidence about such contacts..."

German military collaboration with SA 1981-85 – Germany 19.132

Public hearings on the activities of transnational corporations in South Africa and Namibia, New York, 16-20 September 1985. Paper by Jurgen Datrowsky: West German transnational corporations and military and nuclear cooperation with South Africa. "South African trade with the Federal Republic of Germany (FRG) has been reduced considerably... The majority of FRG companies in South Africa, however, are still present and willing to stay according to newspaper inquiries... Between June 1982 and December 1984 West German banks have been in leading positions managing bank loans for South Africa. At least 48 of the international loans in this period (i.e. 63% of all loans managed by international banks) have been managed by West German banks... The majority of loans managed in the RG and by West German banks have been for parastatal companies in South Africa, of the Government itself... An estimated 400 companies of West German origin are active in apartheid South Africa... Various figures are given for total investment in South Africa ranging from at least R2.7bn...to almost R10bn... A number of big FRG companies, several of them TNCs in the true sense of the definition, are directly and indirectly involved in South Africa's armaments industry": Daimler Benz, HASP, Farbwerke Hoechst AG, Klockner-Humboldt Deutz, Sandock-Austral, Renk, Siemens AG, Karcher. In exchange of know how: STEAG, Rheinmetall, Messerschmitt-Boelkow-Blom, etc. Lots of examples. Stuff on Silvermine.

W. Geisler: Military cooperation between the Federal Republic of Germany and the apartheid Republic of South Africa: "When in films of the racist state there are shown 'Hippo'-vehicles as the most used vehicles of the police in their murderous struggle against e.g. demonstrations of pupils in Soweto, when there are shown 'Samil' vehicles as standard vehicles of the army...then the federal German involvement in supporting the racist rule is immediately evident: the 'Hippo' is an armoured troop carrying vehicle which is built on the chassis of the Unimog military lorry of Daimler Benz." Gives some indication of basis of illegality under FDR law. "Clause 26 of the basic law concerning the peace obligation says: Actions which are suited and undertaken with the intention to break the peaceful living together of the peoples, especially to prepare an aggressive war, are unconstitutional." Sections on breaches of the arms embargo before 1981 and after.

"Military Technology", 1/83, Article on G-5 and G-6: South African does it (almost) by itself. Role of Canadian company SRC-Q (Space Research Corporation of Quebec), in 70s. Mainly quite technical details on technology involved.

AAM Publication – Plessey arms Apartheid, 20/5/81: "Plessey Radar Ltd, of Addlestone, Weybridge, in Surrey, a subsidiary company of the Plessey Group, are currently exporting to South Africa an



advanced military radar system... On 29 April 1981, an Anti-Apartheid Movement member witnessed and photographed the loading of a mobile radar unit and control unit onto a South African aircraft at Hurn Airport in the south of England... The Anti-Apartheid Movement believes that this contract represents one of the most serious violations of the UN mandatory embargo..." More details on the Plessey case.

"The Citizen", 7/1/87 – Kohl denies approving sub plan sale to SA: "West German Chancellor Helmut Kohl yesterday denied his government approved the sale of submarine blueprints to South Africa in defiance of an international arms embargo... West German legislation and a United Nations embargo both forbid the sale of arms to the Republic..."

"Leadership", 4/85 – Interview with Jurgen Schrempp of Daimler-Benz. On Daimler's extensive holdings in SA: "We have always seen and still see great potential in South Africa, and we invest in the country accordingly... And again we have review the situation and have come to the conclusion that while SA might face very, very difficult years politically and economically (as might the company) this country and region has tremendous potential in the long term. That is what counts as far as Daimler-Benz is concerned... The other point is not necessarily a business consideration – call it a moral consideration. We feel very strongly that our presence here will make a major contribution to the wellbeing of, and hopefully peaceful change in South Africa."

"Southscan", 4/5/1990?, Offshore oil project 'used as cover for submarine construction': "Bonn/Mossgas, the Mossel Bay off-shore gas project, was used as a cover for the supply of U-boat plans and the intended construction of submarines, the internal records of the West German firms involved reveal..."

Reinhard Kramer, The Green Party, 7/7/1990 – Most recent developments in the west german submarine affair: "On July 4th 1990 the Regional Court in Kiel… has issued an important decision on the submarine affair. It decided that the delivery of submarine blueprints and know ho for submarine building in South Africa does not constitute a criminal offence but can only be prosecuted as a regulatory offence… It has to be remembered that this authority is not independent like the state prosecutor but is a subordinate authority to the Federal Government and that already in January 1988 the OFD (local tax) authorities has decided that no fine at all should be imposed on the companies…" Details on possibilities going forward.

"Frankfurter Rundscau", 15/9/90 – "Strauss was the 'pressing force in the background' of the submarine deal, new documents place also Chancellor Kohl and advisor Teltschik in difficulties... On Friday, the State Prosecutor in Bonn unexpectedly released an investigation file against the ministerial director in the Chancellor's Office, Horst Teltshik (CDU), to the public which had hitherto been kept a classified secret matter. One of these document...reveals that both Chancellor Helmut Kohl and his foreign affairs advisor Teltschik allegedly knew the planned dates of delivery already before the smuggle of submarine construction plans to South Africa commenced...It was known that Franz Joseph Strauss promoted the deal vehemently..." Letter from Bernie Grant, MP in British House of Commons, to Hungarian Ambassador, 4/1/90 – Visits by South African ministers to Hungary: "I understand that Mr Pik Botha, the South African Foreign Secretary, has already visited Hungary and that there are plans for the President, Mr De Klerk, as well as others to visit. I further understand that Hungary is preparing to trade substantially, with South Africa, even to the extent of breaking the United Nations Arms Embargo on South Africa. I hope that my information is not correct and that there is no such intention on behalf of your Government. If this is the case I would be obliged if you could issue a statement to clarify your Government's intentions in this very contentious area."

"Brief notes of the meeting between Bernie Grant and the Ambassador at the Hungarian embassy in London," 8/1/90. Following questions on the relationship between Hungary and South Africa, "The Ambassador responded by explaining what he saw as the two realities which guided the decision of the Hungarian Government. "Summary of findings until now", mentioning Dirk Stoffberg, Joseph Klue, etc. "Stoffberg and Klue are the tip of the iceberg. There are various levels of 'dirty work', including recruitment of criminals, the creation of covers, the entry of spies and their commanders (SA security police), dealing in arms, gathering of intelligence – often with help from right-wing institutions in the UK – and collaboration on a high level with political authorities, businesspeople, police and intelligence." Various theories ramblingly laid out, with little support. BOSS, Leslie Aspin, Gary van Dyk, Craig Williamson, Niemoller etc. Conclusion that there is a lot of illegal activity going on in Britain by SADF, Armscor, NIS, businessmen, ex-intelligence officers etc. The "only possible conclusion is that political high level collaboration between SA and the UK, with one aim: fighting the 'communist enemy'...makes it possible..."

All we need is a decent life, where blacks can be recognised as human beings and truly say they have a country to which they belong and can defend, that is South Africa. Finally this means the right to decide by vote who our leaders should be or not be. This is what the sanctions campaign is all about."

5/7/89 Letter from Anthony Mongalo, secretary for presidential affairs, to Jean-Charles Demarquis, deputy head of French mission in Lusaka, requesting visas for Temba Safa, Kingsley Phomolong and Thami Sindelo, who will accompany Tambo to Paris.

Top Secret magazine 1992 – Germany 52.36

1/92 Article: "Operation Thunderstorm's bloody balance sheet, by Billy van der Merwe, Jack Umshini Wkubhala, M Opperskalski". "Operation Thunderstorm was born in the summer of 1990, after the balance of power within the South African secret-service community — especially the balance between NIS and DMI — had clearly tipped in favor of the NIS. Operation Thunderstorm is headed by an ultra-secret team consisting of the top leadership of NIS and DMI... Describing the core of Operation Thunderstorm, a senior official of the ANC Intelligence Department says: »Every plan and action — particularly on the question of violence — is aimed at weakening the ANC so that it is eventually forced into a constitutional coalition. USA Israel SA missiles 1991 – London 54.74

24/5/91 Article from Financial Times: "CIA 'knew' of illegal US missile deal" – "US ballistic missile technology and military equipment was shipped illegally to South Africa between 1984(?) and 1986(?) with the full knowledge of the Central Intelligence Agency, according to American officials... The illegal missile technology shipments to South Africa and other violations are expected to result in indictments in the next few weeks..."

17/5/91 Article from "SS" (Southscan?): "Israel anti-missile missile stalls on issues of South Africa sales" – "A disagreement over technology transfer has stalled negotiations on a US-Israeli 'Star Wars'



project... Israel is helping South Africa on a number of missile projects, receiving in return funding for weapons development, primary materials and use of South Africa's Arniston testing range."

11/1/91 Article from Southscan: "Israel rapped by US after SA missile test?" – "When Israeli Prime Minister Yitzhak Shamir visited Washington late last month, Secretary of State James A baker warned him about Israeli exports of technology... The US sources who disclosed the warning said they surprised, because there hadn't been any recent reports of Israeli military sales to South Africa. However, observers here believe Baker may well have been reacting to reports of a South African missile test in November that was almost certainly a joint venture with Israel. 7/5/87 Letter from Ursula Eid, Greens MP to "Your excellency", enclosing speeches of Abdul Minty as delivered at a workshop. "As you may have learned from reports in the press, the Bundestag has decided to re-establish the investigative commission on the sale of submarine construction plans from the FRG to South Africa."

Text of Abdul Minty speech of 9/2/87 Bonn attached. Deals primarily with case of provision of submarine plans. *"It it important to recall that the original arms embargo was first adopted by the Security Council of the United Nations during 1963/64. At that time the Federal Republic of Germany was not a member of the United Nations but it gave both written and verbal assurances both to the United Nations and other organisations and governments that it would comply with the resolutions – letters and other documents to this effect are in the files of the United Nations, Britain, the major arms supplier to South Africa, was replaced after a period of years by France. As the FRG moved into the South African economy during the 1960s...your companies also began to participate in the newly developing internal armaments industry in South Africa... World campaign against military and nuclear collaboration with SA 1983 – Tambo 86.913

23/9/83 Text of statement by Abdul Minty "to a closed session of the Security Council Committee on the arms embargo against South Africa": "Indeed, during the almost six years of operation of the mandatory arms embargo, we have witnessed an ever-escalating expansion of the South African military and para-military forces, with a commensurate addition of equipment acquired from abroad. During this period, we have also seen substantial evidence of its enhanced nuclear weapon capability, to such an alarming extent that even the major western powers today concede that there is the real danger of nuclear proliferation arising out of the South African nuclear programme... In earlier representations we have raised the question of examining the relevant legislation of Member States in implementing the mandatory arms embargo. This still remains one of our major concerns and we hope that the Committee can also give attention to it. However, due to lack of resources we are unable to make a comprehensive study, but if other Governments could provide the Committee with the text of their legislation, it would assist us all in enforcing the embargo more effectively..." Lists some recent examples of sanctions busting, e.g. Marconi, pistols from Austria, Trigon. Difficulty in getting information from countries/companies. Appeal for help. "There is one other problem to which we should like to draw the attention of the Committee, namely the role of South African diplomatic missions in violating the laws of host countries." London and France mentioned. Long speech.

World campaign against military and nuclear collaboration with SA 1987 – France Add 9.158

22/5/87 Cover note from Abdul to Dulcie, noting: "If there is anything I should know please drop me a note". Attached, 24/2/87 campaign newsletter. "We are enclosing some information about this case [sale of submarine construction plans to SA] which has not received much publicity outside West Germany and hope that you will be able to take some action to support our efforts..." Attached document gives details on case, as might be given to media, form basis of campaigns, letter writing etc.

3/6/87 Reply from Dulcie to Abdul. "Also, could you investigate the constant reports of France's arms sales to South Africa. I know that it is not easy because of the secrecy surrounding this matter, but I think some means have to be found to embarrass France. I feel that it is too much silence regarding

World conference against apartheid etc. 1977 – Tambo 58.553

16-19/6/77 World conference against apartheid, racism and colonialism in South Africa, Lisbon. Paper on "South Africa's military build-up" by the British AAM. 15 page document on failure of embargo, military collaboration with SA by Britain, France, USA, FRG, Italy. Good basis for 1970s state of play.

Resolutions of Economic Commission. "Without the support of the imperialist state and their agents the racist, colonialist regimes would have long crumbled... The multinational corporations have, until now, been able to evade all form of international sanctions with the aid of the hypocritical policies of their governments which while proclaiming moral condemnation for the racist regimes at the same time permit and even encourage their corporations to collaborate with them." Multinationals condemned, called to stop economic collaboration with SA, stop extension of loans etc.
