Reunert (for US, UK, Germany, Israel, UAE, Saudi Arabia, Argentina, Uruguay, Paraguay, Chile, Poland, Slovakian Republic, Romania, Turkey, Italy, Zcecho Republic,

France, Spain, Malaysia, Brazil, Spain, Malaysia, Brazil, Canada, Pakistan, Thailand, Singapore) – vehicle mounted mine detector system, with applications. ESD (for Chile) – various items. Naschem (to USA) – clients are Day & Zimmerman of USA. Sandock Austral (for massive list of countries) – includes clipping pertaining to export partner, Alvis. Swartklip (tons of countries), lots of items.¹

[Mr A Trimark (Swede) of SA Import-Export offers to sell Rolls Royce parts to SA via Copenhagen (1/6/82) – Armscor writes to offer thanks but arms not required.]

News clipping on SA arms sales abroad. 1982: Spanish request for weapons. 1982: Secret memo response to Armscor media interview, note of the negative impact this will have. 1982: Sri Lanka, Thailand. 1980: Bolivia. 1984: Swiss Arms Trade discovers Swiss govt intention to import: Mr Richard Ritter, Pan Atlantic AG.]

[Symon S Behrman involved of illegal export of weapons to SA (1988-1990). Symon Morris Behrman (USA), Maryanne E Callaghan (USA), Guy Perfezon (RSA in France?), Frank Randazzo (USA), Lester George Buchanan Talnot (USA). J. Eugene Burke (Irish American) offers to export weapons to SA (1985). Offer from Klaus Schaper to sell weapons to SA (1985).]

1980/10/14 Mr John Gelernter, MD of Cibo, "one of the Bolivian firms which act as local agents for several South African exporters..." says Bolivia prepared to make several large orders with SA firms, on credit. Mining equipment and arms. "COMIBOL always pays its debts".²

1980/10/26 Mr CL de Roover, La Paz businessman, claims govt. of Bolivia is interested in purchasing, inter alia, 6 patrol boats. Credentials questionable, and thought best to deal with Bolivians directly, not through intermediaries.³

1981/1/12 Cover letter on SADF help to Greece. No details.⁴

1981/6/2 Sri Lanka request for manufacture of Browning machine guns. Require existing models for evaluation, SADF requested to make loan of one for three months.⁵

1981/6/2 Thailand makes request for hand grenades. Need loan of 64 from SADF for evaluation.⁶

1982/10/8 Ammunition requested from Spain. Stock to be sent from SADF (to be replaced by Armscor), shipped from Cape Town urgently.⁷

1982/11/24 Armscor approached for purchase of G5 cannon. Suggestion made to make technical presentation to Iraqi ambassador in Bonn. Question of authenticity of intel. Advise not to use phone.⁸

1982/11/26 Iran arms for oil. Various previous approaches from Iranian agents have come to nothing, it is believed for political reasons. This one from Mr Shmuel Kirsenzvaig. Gives details of oil

price offer, parts and ammunition request. "He mentioned that while the Iranians could obtain Russian equipment, they desperately wanted spares and ammunitions for the US equipment originally obtained during the Shah's reign."⁹

1982/11/27 Financial Mail clipping: "South Africa takes aim at selling arms abroad". Peet Smith of Armscor boasting of tech successes.¹⁰

1982/3/29 Text for official news bulletin. Advertises new G5 cannon, as helped along by a Canadian affiliate, including through arms theory tests in Canada and weapons tests on Antigua. Note that this text is considered dangerous, as it makes people unwilling to become involved, fearing later exposure.¹¹

1982/6/1 Copenhagen to PTA. Swedish citizen Mr A Trimark, airline pilot, sole proprietor of SA Import-Export, offers large quantity Rolls Royce Avon jet parts. Didn't want to be spotted at the SA mission in Stockholm. Armscor responds saying thanks but no need.¹²

1983/? Cover page of 1983 Report on Arms Control and Disarmament. Handwritten notes on page, say little.¹³

1984/1/26 Peru calling for tenders for 5 frigates. "*Apparently no political reservations in dealing with RSA*." Greece is looking for sizeable quantities of laser beam distance measuring equipment.¹⁴

1984/11/28 Mr R Malek and purchase offer from Iran. Armscor (Peet Smith) to contact directly and check credentials. Issue of whether proposed Iranian travel to SA is to be on diplomatic or private passport. Malek, "of Kinross", claims to have been referred to Minister of Foreign Affairs, Botha, by Ters Ehlers.¹⁵

1984/5/1 Enquiry on the shipment of arms from SA. Ambassador Vorster draws attention to a document and notes that it is not always clear whether the Department of Foreign Affairs is entirely au fait with such issues. Document states that Mr Richard Ritter, director and owner of shipping company Pan-Atlantic-AG, of Bonn, approached NS Schoombie and Mr Eckard. Claims to have done major tenders for Swiss gov. Offers services, in various named forms.¹⁶

1985/? Letter from AB Greenham, DG DFA, to Geneva permanent representative, re: Trade offer. Following various correspondence, *"it would be appreciated if you would indicate whether you are now in a position to make a recommendation on Regimpex SA."*¹⁷

1985/11/26 Mr Eugene J Burke, business partner of Charles Banks, of Applied Electro Mechanics (USA), makes offer of Aerial ground surveillance systems at Sydney embassy. Attaches newspaper clippings and other supporting docs on Applied Electro Mechanics.¹⁸

1985/3/19 Armscor has no interest in buying second hand military equipment from Europe via Australia, from Klaus Shaper.¹⁹

1985/4/?/ Letter from AB Greenham to Geneva permanent rep. "*It would appear that the offer concerned would be of interest to Armscor and/or the Strategic Fuel Fund.*" First, request for as much detail as possible on Regimpex and directors, plus recommendation on that basis.²⁰

1988/10/11 Press release from US attorney that "Thomas Joseph Dolce, former civilian employee at Aberdeen Proving Ground, Maryland has pled guilty to a charge of espionage relating to the furnishing of defense-related classified information to a representative of the South African government." Full statement of facts charges etc.²¹

1989/11/20 Court documents "pertaining to the indictment of three South African and two American on charges of conspiracy to export gyroscopes to South Africa". Symone Morris Behrman, Maryann E Callaghan, Guy Perefezou, Frank J Ransazzo, Lester George Buckingham Talbot. Related newspaper clipping from Business Day 4/1/90.²²

West Germany

[1981 Decisions is taken that SA want replace MA. Instead SA&Germany agree that they will ? GI Potgieter in a 'covert' capacity as attaché. The Germans are in agreement as they want a channel for communication.]

[1983 Germans see no possibility of replacing MA despite Kohl election. Recommendation to send military person under the cover of a civilian diplomat. They decide not to inform the German Ministry (modus Vivendi). Later German Chancellor informs them that they approve of this arrangement. Although MoF want Botha to write a letter.]

[Details of Military Attached who will work as a civilian in Bonn. Letter from Botha to Kohl asking for full MA accreditation.]

[Handwritten notes: - Offer from Lengfelder to sell weapons. – Offer: Mr Buch/Buck to supply weapons (rejected). – Exchange of used arms & info (SADF w. German Intelligence). – Export of arms by Rheinmental to SA (Der Spiegel). – Mr Gerhard Mertens/Merex. – Consideration of business with Adolf von Thadden & Flick Co. not entered into (1977). Right-winger. – Uranium enrichment.]

1977/10/14 Bonn Ambassador to DFA, with von Thadden offer. Thadden is former chairperson of the National Democratic Party of Germany, extreme right, makes cooperation a political risk. Firms

referred to is Flick. Details of weapons offered. Third country to send weapons through – Singapore.²³

1977/2/24 Message from Secretary of Foreign Affairs to The President of the Atomic Energy Board, on "alleged co-operation between West Germany and South African in the field of nuclear energy and armaments", attaching docs from Bonn Ambassador. Docs relate to logistical details (e.g. shipping, payment) of sale of compressors for use in uranium enrichment to SA, and of fire alarms for the SADF.²⁴

1977/2/9 Letter from Ambassador to Secretary for Foreign Affairs, on compressors sale and Dr W Geissler (of Director of Prosecution) case. Involves firm MAN, Escom, STEAG.²⁵

1977?/?/? Letter from Paul Koch to Mr von Thadden, making offer of rocket launcher and speedboat to be provided to "an African country", with methods proposed for getting around arms embargo.²⁶

1978/3/23 Bonn Ambassador to Secretary of Foreign Affairs, on meeting with Mr Gerhard Mertins, "head of MEREX group of companies whose main line of business lies in sales of military and related supplies". Explained that "*in March 1978 he had been requested by General van den Bergh to assist in establishing contacts with a view to direct oil supplies with Saudi Arabia as well as overflying rights over Egypt and the Sudan for South African Airways.*"²⁷

1979/2/2 Armscor to DFA, on Adolf von Thadden offer. No interest at present in offered items. Following document, 25/1/78 asks for info as given.²⁸

1980/8/11 Translated from Der Speigel – "Prosecutors and Investigators of the Federal Criminal Investigation Office struck gold: arms of the Rheinmetall concern illegally reached foreign countries... the investigators found Rheinmetall arms...in crisis areas like Argentina, Saudi Arabia and South Africa." Many pages on this, on process of getting approval from Bonn, processes of supervision etc. Original attached.²⁹

1980/8/15 Reports on Frankfurter Rundschau report. Notes that publicity may raise again the sensitive issue of the SA Military Attaché in Bonn. Also question of how to approach situation, given possible outcome of official investigation.³⁰

1980/8/15 Translated from Frankfurter Rundschau – AAM accuse Rheinmetall of delivery of weapons to SA, reports to UN. Also mentions Space Research Corporation International in Brussels. Original attached.³¹

1981 Handwritten note: von Hirschberg. Concerns over communication between Bundeswehr and German Ministry of Foreign Affairs, and whether authorisation for undercover Bonn MA from former

would have been approved by latter. No possibility of secrets in Bonn. Thought best to clarify through military channels. Another doc, 16/4/81, clarifies: "As ons 'n offisier onder dekking in Bonn aanstel, sonder die medewete van die Duitse Departement van Buitelandse Sake, kan probleme ontstaan... [one opinion:] as die Duitse Weermag nie met die Duitse Departement van Buitelandse Saje uitgeklaar het nie, is dit hulle probleem." But don't want any embarrassment, as military authorities can later deny approval.³²

1981 Various admin docs on Potgieter appointment.³³

1981/3/5 Current Bonn MA, Commodore Bitzker, has had term extended by a year. Decision not to place another in Berlin, as possibility of being seen as slap in face of W Germans. Germans keen for undercover SA military representative in Bonn. Relations with Bundeswehr are excellent, W Germany only country willing to share essential NATO codification(?) data. Col GI Potgieter to be placed in Bonn.³⁴

1981/4/3 "As 'n lid van ons Departement sal dit dus, veral vir die Buitelandse Ministerie in Bonn, heel gou duidelik word dat daar 'n amptenaar op die Ambassade lys verskyn wat nie 'n 'normale' diplomatieke beampte is nie." Tension in the first place a result of elements in German DFA not supportive of SA. If military communication needs can possibly do without, best not to. German political situation uncertain, best to wait. But Berlin option not to be so quickly dismissed, as it is rather the Bonn government who slap SA in the face by not giving approval for replacement of Bitzker.

1981/5/25 I Kroukamp advises that there are only two real options: extend current MA's time until specifically asked to close military office, or that the army trains a bona fide DFA official to meet needs, and close office now.³⁵

1982/12/15 Letter from CSADF to DFA on exchange of captured arms with W Germany. Good ties with German MI led to offer of exchange of seized Soviet equipment. Potential benefits listed, recommendation given. List attached of items to be transferred.³⁶

1983/6/21 German Minister of Defence, Mr Worner, claims to be categorically in favour of an SA military mission in Germany, in disagreement with previous government. Will personally raise with Chancellor and with Minister of Foreign Affairs, Mr Genscher (who is of a different mind). Much disagreement within the coalition.³⁷ Numerous other docs on the political issues involved in this issue, discussion held, etc. DFA claim decision based on SA treatment of Germany (e.g. visa and travel restrictions). Early 84 sees seeking of a modus Vivendi, such that SA can't be accused of deception.³⁸ Bitzker term by now extended to 7 years. Genscher believed to have informants in MoD. Chancellor requires Genscher for coalition stability. Possibility for Bitzker to go "on leave" to

SA, return to Bonn at regular intervals, while military person secretly goes in civilian capacity to take over functions. Mind 84: PM sends a letter to Kohl.³⁹

1984/1/27 Note from Hamburg to Pretoria, with Buch offer. Firm called Lisa Koerter, known arms dealer. Willing to give names and addresses of arms dealers dealing with Southern African freedom fighters: Mr Allen, Col Escot, Trentgold (all UK). Offer to make purchases to gain trust, gain complete intel. In exchange, wants SA passports for self and girlfriend, assurance of shelter if things go wrong, anonymity. Asks for info on what Swapo might want, to make purchase believable. Description/impressions of Mr Ingold Buck. He provides some information on shipments to Swapo.⁴⁰

1984/1/31 Note (from Pretoria to Bonn?) advising that Mr Buch's friendly offer be rejected, as doubt over bona fides, suspicion that offer may involve attempt at immigration. Note also that although SA aware of source of weapons to "freedom fighters", it would be grateful if Mr Buch had such info to pass along.⁴¹

1984/8/6 Letter from RP Pretorius, Foreign Procurement (FP), to DG DFA, regarding Lengfelder offer from Munich. No interest.⁴²

He will be in Zaire (?) indefinitely and should arrive 1200 hours local time today... He is aware of every transaction that

pertains to Republic of South Africa requirement from first transactions with Commerce International and CSF (loan(?))... He must not repeat not be contacted. He will make contact with your liaison officer within five(?) or six days."⁴⁴

1976/1/27 From Ambassador for Armaments Board, asking if arrangement with Frost continues in respect of names weapons.⁴⁵

1976/11/19 To CSI. Project Mattbet members have not received money, cannot draw further from their associate company, required USD20,000 urgently "to save them from embarrassment".⁴⁶

1976/11/25 MANA to CSI and Armscor. Project Sherbert, receipt and delivery consignment acknowledged.⁴⁷

1976/6/22 Deprod PTA to Col Lombard, on offer received from Willy Pourtois reference Bruno regarding enquiry for ammo, instruction to check with him urgently whether ammo is armour piercing and confirm price.⁴⁸

1976/9/27 From CSI to MANA. Consignment contents for Project Burrow (sight, lighting instrument, maintenance manual), in Diplomatic bag, to be delivered to Mr Tienie Smith of the evaluation team.⁴⁹

1976/9/29 From CSI to Armscor, on Project Sherbert, air cargo – personal effects for evaluation team. Various cases to be delivered to MJ Smith, CP van der Westhuizen, D Oosthuizen. Also case for Project Burrow to be handed to Mr MJ Smith.⁵⁰

1977/3/1 From MANA (military, air and naval attaché) Brussels through Ambassador to Armscor, on Project Sporadic. "May Clark and Peletan proceed as discussed… the project is possible. Twenty S plus W can be obtained free on board New York US Dollar 175. Shipment per SAA. … Confirm quantity N 16 A 1 needed… When replying on telephone please answer numerically i.e. if four is yes just say so." Lots more in semi-code.⁵¹

"Pheasant has indicated that due to early delivery of the goods ex Sofia...he will not be able to visit South Africa as intended to discuss security aspects in respect of two shipments and Kegelraeder flight... The specific request is that SAN unit stand by 600 to 1000 repeat six hundred to one thousand sea miles south Las Palmas to shadow convoy ship..."⁵³

1977/4/28 MANA to Armscor (via as usual). Partly in code, e.g. "Sherbert Two".54

1977/4/29 From Armscor, via DFA and Ambassador, to MA. Request for cheque of BF1,946,000 to be forwarded to Col. Lombard in Brussels, for payment for 200 pistols obtained from Mr H Ledent. Transportation arrangement to be made.⁵⁵

1977/5/17 Armscor to Brussels MA via DFA and Ambassador. Info for Josef Lambrechts, on establishment of new company Orion Trading Establishment, with share capital FS30,000 (minimum), and "mandatarisse: M Johnson, PR Polansky, JS Cantor, F Neumann".⁵⁶

1977/6/16 Ambassador to DFA, for SADF. Belgian intelligence refuse to make copies of documents available to MA, but are willing to circumvent the ban, so docs to be left for half hour each with MA, and notes can be made on chapters of interest, and intelligence will then make summary available.⁵⁷

1977/6/24/ Ambassador to DFA, for Armscor, on numerous items (bombs, rockets, cartridges etc.). Cheboub asks for prices (to include 12% commission) to be provided. Switzerland's "neutral" position on SA is largely a result of the influence that bankers have on politics, and the social relations that SA ambassadors have with Swiss bankers are thus vital. Understandably, details on this not given. This situation was not raised in the recent general meeting between SA and Swiss government reps and officials, but instead raised in private between the PM and President Schlumpf. The President of the Swiss National Bank, the President as well as the Chairman of the Board of Cirectors of the "Bank for International Settlements", and the GM of the Union Bank of Switzerland are in on it, among others. Some other reasons for need for experienced Ambassador, including the unusually broad scope of propaganda services, formerly under Department of Information.⁸⁰



1981/07/02 The Citizen – "Anglo American is US No 1" – "Anglo American Corporation of South Africa, is the biggest foreign investor in the United States according to Forbes magazine… Anglo American owns 32 percent of Engelhard Minerals and Chemicals in the US, 50 percent of Inspiration Consolidated Copper and 55 percent of Terra Chemicals, a fertiliser producer. Forbes values Anglo American's total US assets at \$17 600-million." ¹³⁵

1984/5/16 Paris to PTA. Next meeting in Munich in July. Requests that "Gavin Relly of Anglo American, Basil Hersov of Barclay's Bank etc. as well as pop Fraser be informed that they will be receiving invitations."²²⁴

1984/6/25 Paris to PTA, reporting that Gavin Relly of Anglo-American and Basil Hersov of Barclays have received letters signed by Franz Josef Strauss inviting them to the July Cercle meeting in Wildbad Kreuth, as guests of the Hans Seidel Foundation. Relly conveys regrets, can't at this late stage be in Germany then.²²⁵

1985/4/23 DG to Paris Ambassador, noting no objection to latter's attendance of Cercle meeting in Bonn, 27-30 June. 3/4/85 Letter asking for above.²²⁶

Summary of January 1991 bilateral meeting between SA and Ciskei on financial relations. B J du Plessis's synopsis of the RSA economic situation mentions: "We are overspending – you and us. We are wasting a lot of money. We must get rid of corruption, both of us. Gaps in your tax system and in

I can control each item of expenditure and I would welcome any arrangement which will ensure financial control and discipline. I cannot accept the responsibility for squandering money."²²⁷

Kamil files

1972/5/30 Blantyre Ambassador informs DFA that Malawian Minister Muwalo has assured that Oppenheimer organisation will not have access to hijackers or documents.²²⁸

1972/5/30 Telegram from Beirut Consul-General, passing on Lebanese regrets for citizens' involvement, commitment to Malawian process and possible Lebanese punitive measures too. Comment made that this is happily inconsistent with previous reports about Lebanese request for extradition to SA.²²⁹

1972/5/30 Report of meeting between Mike Geldenhuys of BOSS and PM, and fact that Oppenheimer's secrutiy people are keen to find out if Kamil has certain papers, wish to go to Malawi and try to get access. PM advised that Malawi be encouraged not to allow access.²³⁰

1972/6/2 Beirut Consul-General to DFA. Mrs Kamil, wife, back in Beirut, asking for assistance to get her access to Malawi. Response TBD.²³¹

1972/6/9 DFA to London and Blantyre embassies. No objection to pilot going to Malawi to help with enquiries. Information given on Dr Nicholson, married to Kamil. Note "for President Banda's confidential information political views strongly leftist".²³²

1972/6/14 SAP to DFA, on when Kamil first came to notice, what is known of him (e.g. criminal history in illicit diamonds, spending habits), the incident in brief.²³³

1972/6/27 Blantyre embassy to DFA, informing that Van Zyl, of Oppenheimer security section, has offered full assistance to Wadeley, chief of Malawi Special Branch.²³⁴

1972/7/3 Blantyre to DFA, on tale that Kamil has told Dr Banda. Banda asks whether Kamil was ever, as claimed, employed by SA Intelligence. Also extradition issues.²³⁵

1972/7/5 Response, including that President be informed that this last is entirely untrue – "nobody in Military Intelligence knows Kamil".²³⁶

1972/8/22 Considered of potential interest to hear what Kamil has to say, but open cards with Banda.²³⁹

1972/8/25 Blantyre to DFA, providing copy of charge sheet, and some explanatory notes.²⁴⁰

1976/5/12 Report from Glasgow Consul-General of interview with Kamil on BBC. Focused on role of an "International South African Corporation" in trying to discredit certain UK politicians.²⁴¹
